- 2. Invocation was offered by Col. Wm. Hays.
- 3. Pledge of allegiance to the flag was done.
- The 2009 Officers were sworn in by Col. Wm. Hays. 2009 Officers are as follows: President – Chuckwagon Sam Vice President – Deputy Keck Treasurer – Whip Wagner

Secretary – Bdoc Safety Officer – Dip Match Results – SloPoke Sara and Mattie Hays Territorial Governor – Vegas Kid Special thanks to all who were officers or have helped in any other way!

- 5. Minutes of the last meeting were read and approved. 28 members attending today.
- 6. Treasurer's Report Checkbook balance as of today is as follows:
 - For RJSS: -\$63.03
 - For Ambush: \$5030.58
 - For Smoke N Fire: \$1652.84
 - Total in Checkbook: \$6143.00
 - All bills for 2008 have been paid.
- 7. Motion was made, seconded and carried to accept the following new members:
 - A. Dave Aubele AKA Mariah Kid
 - B. James Collins AKA Gray Squirrel

A hearty welcome to our two new members. Motion made, seconded and carried to close the charter.

- 8. ICVSA Liaison Report: ICVSA wants to know where the AED would be stored where it would be accessible to both clubs. Also if people will be trained by professionals on it's use and it's liability to the club and the people who use it. Deputy Keck will talk with Dr. Mary Walker about this information along with the cost of an AED machine.
- 9. Club Contact Report: Tombstone Timi has nothing to report. Timi requested for someone to take over as club contact. If anyone is interested please see Chuckwagon Sam.
- 10. Territorial Governor Report: Col. Wm. Hays reported the following results from the Las Vegas Convention, and much discussion was had:
 - A. Should Traditional and Modern categories be combined and then split into two age-based categories? Pass
 - B. Should Gunfighter style shooting be allowed in all categories except Buckaroo, Buckarettes and Juniors? Fail
 - C. Replaced the line "The displaying of sponsor's or team logos on apparel is prohibited. Manufacturer's labels on such apparel or equipment are acceptable" - Pass
 - D. Added "All horizontally staged handguns must be staged with the entire handgun lying flat on the staging surface" Pass
 - E. Clarification "ALL clothing and equipment MUST BE worn appropriately, how it was intended and how it would have been worn in the OLD WEST or as seen on B-Western movies and Television" Pass
 - F. Should we allow a shooter to retrieve a dropped round? Fail
 - G. Replaced the line "De-cocking may not be done to avoid a penalty if cocked at the wrong time or position. NO gun may be de-cocked on the firing line except by pointing it down-range and pulling the trigger or while under the direct supervision of a stage officer" Pass
 - H. Should we change the rule regarding empties left on the carrier or in the chamber of a long gun? – Fail
 - I. Should we allow gunfighters to carry revolvers in the butt forward manor? Fail
 - J. Should we allow ejectors on single shot shotguns? Pass
 - K. Added "An alternate target MUST be provided for all aerial shotgun targets for Buckaroo and Buckarette shooters Pass
- 11. Vice President/Ambush/SNF Report: Deputy Keck informed everyone to keep reading the Epitaph for updates regarding Ambush and SNF. Deputy Keck reported that he and Gray Squirrel handed out flyers out in Las Vegas and from the response he does not believe that there will be a good turn out in regards to prizes. Even though he already has \$1000 in prizes there will not be enough for everyone. This year people will draw a chip and if that chip has a number on it then you win the prize that corresponds with it, but if the chip is blank then no prize is won. Durango Dave stated that in the past many members have stepped up and donated prizes and that is a great help to the club.

12. Old Business:

- A. The Winter Gathering will be held at Ladle's In the Mountain on Saturday February 21st at 6pm. Please let Tombstone Timi know by February 20th if you plan on attending. A costume contest will be held and everyone will be able to vote for the winner. Cowboy costume/attire not necessary to attend! Come out and join the fun!
- B. Chronicle Ad: We are registered with SASS and the NRA for the Ambush and SNF and the ad and the money (\$200) were sent in December by Deputy Keck and the ad will run in the April Chronicle. Deputy Keck stated that Chuckaroo's publishing will be more beneficial to us and the Ambush and SNF will be mentioned. A special thanks to Mattie Hays for the wonderful article about last year's shoot!
- C. NRA Grant: Durango Dave stated that financial statements need to be gathered by Whip and have to be sent to the NRA. The NRA needs the receipts of the activities that RJSS uses the money from the fund for (Community Day). Durango Dave will keep us posted.
- D. Election Process: Likes and Dislikes:
 - Don't like having the election officer end up running
 - Mail out ballot for those that don't make all the shoots or have email
 - \circ Put the ballot in the Epitaph and have people mail it back in along with having paper ballots at the shoots.

Motion was made, second and carried to put the ballot in the Epitaph and for people to mail it in if they want to along with paper ballots at the shoots.

- 13. New Business:
 - A. Two Year Terms for Officers: Chuckwagon Sam feels that this would be a good idea along with Officers becoming official as soon as they are elected so there is no down time. A straw poll was taken of the members and received their approval to look into this further with the Bylaw committee.
 - B. Updating Bylaws: A committee has been formed consisting of Chuckwagon Sam, Deputy Keck, Vegas Kid and Col. Wm. Hays as the advisor. Nothing has been done as of today.
 - C. AED Update: Discussed earlier. The cost looks to be around \$1300-1700. State law covers the use of AEDs (part of the Good Samaritan law) so our insurance should not go up. Possible ways to obtain AED:
 - Selling of old targets
 - Contribution jar with a sign at the registration asking for donations
 - 50/50 tickets
 - Durango has a grant application from Excela Health
 - Masonic, Elks, etc help with donations and/or buying of AEDs
 - Barleycorn will head a committee to raise money for an AED. Any additional volunteers would be appreciated!
 - D. Road Signs: Have already been repainted. The sign at the main gate will remain the way it is until it is know how much it will cost to replace. Whip will look into the price of a new sign.
 - E. Ambush Trophy status: Everything is taken care of.
 - F. Regular Match Prize: Every month RJSS will give away 1 FREE shoot certificate for a regular match as a random prize. Winner must be there to collect!
 - G. Membership dues same
 - H. Shooter fees same
 - Motion was made, second and carried to give a free shoot to new shooters of RJSS (excluding SNF, Ambush and extra shoots)
 - I. SNF fees same
 - J. Ambush fees same
 - K. Road Repair update: Two loads of gravel were purchased at contractor price along with the pipe for under the road. Road will be repaired once there is a break in the weather.
 - L. Host the SASS PA State Shoot: Much discussion was had on this topic. At the end it was decided for RJSS not to put in as host of the PA State Shoot.

- M. SNF 2010: Deputy Keck will continue to run SNF
- N. RO1 Course: Nothing is happening right now: waiting for a break in the weather in order to get some time on the range.
- O. Epitaph The Epitaph will be mailed out by Bdoc to those that do not have email. RJSS lists will be cleaned each year and only those that reapply for a membership will receive the Epitaph. Anyone is more than welcome to write an article for the Epitaph. Please have it in to Chuckwagon Sam by the last week of the month.
- P. Durango Dave resigned as Treasurer and Whip Wagner was gracious enough to continue! Thanks!!
- Q. Deputy Keck has two gun tickets available \$15 a piece
- R. SNF/Ambush flyers are available
- S. Cards are available with the clubs information on them. Please take and give them to your friends! Thanks to Chalkdust and Surly Sal!
- T. Whip stated that we are having issues with the food bank that we donate 10% of our profits from the Ambush. They have not been cashing our checks on a regular basis. One suggestion was to write only one check a year.
- U. Motion was made, second and passed to pay for Deputy Keck's ICVSA dues so he will continue to serve as our liaison
- V. Our thoughts and prayers go out to Miss Dorothy as she continues to battle against Breast and Brain Cancer.
- W. Motion was made, second and passed to pay for half of the fees incurred by Deputy Keck as a TG at the Las Vegas convention
- X. Cutter Kid has two prizes obtained by Fuzzy (duck target and a SASS bobble head both signed). Tips will be sold for \$5 a piece until all are sold. The winner will receive the duck and the prior number will win the bobble head. All proceeds will go to the club. A big thanks to Cutter Kid!
- Y. 63 people have renewed their memberships!
- Z. 50/50 Total was \$72. \$36 was won by Susannah Fife

Should we combine the Traditional and Modern categories and then split this combination into two agebased categories, with the age breaks being at 17 and up / 36 and up? This would give us age-based categories for all ages. All age based categories would allow the use of all SASS legal firearms, propellants and shooting styles except Gunfighter. Percentage 194 (for) 69.78% 79 (against) 28.42% 5 (abstain) 1.80% PASSED 2. Should we allow the use of the Gunfighter shooting style in all categories that allow two handed shooting except Buckaroos, Buckarettes and Juniors? Percentage 137 49.28% 140 50.36% 1 0.36% FAILED 3. Should we replace the line - "Outlawed - Clothing displaying manufacturer's or sponsor's logos" with "The displaying of sponsor's or team logos on apparel is prohibited. He explained the differences in this revolver and the Ruger Vaquero model. Discussion was both in favor and against the firearm. The majority in attendance were in agreement that the Montado hammer is of no concern but were not in favor of allowing the Montado front strap serrations. Coyote Calhoun will convey these desires to Ruger for action shooting requirements. A vote was taken of the TG's in attendance and the Montado hammer style was overwhelmingly approved for use for Action shooting.
